- Business revenue is projected lower due to less funding available for businesses outside of partner city footprints
- Residential transport revenue includes a rate increase of \$4 per month on most popular products

- Currently seeking bond rating which could release debt service reserve funds, if released it
  is possible a bond will not be needed during FY 2025 and a rate increase will not be
  necessary
- Distribution checks sent to member cities last week for \$4.3 million to help repay bond, \$4.6 million projected next year
